#### 4.1 Resource Efficiency:

- I. Implement measures to optimize the consumption of raw materials, water, and energy.
- II. Utilize advanced technologies to improve resource efficiency in our operations. Monitor, measure, and report our resource/material inventory, including coal, wood pulp, diesel, water, etc.

#### 4.2 Targets For Responsible Resource Consumption:

- I. Achieving a 30% reduction in Freshwater Consumption Intensity by 2032, using 2021 as the baseline year.
- II. Achieving a 20% reduction in Energy Consumption Intensity by 2028, using 2021 as the baseline year.
- III. Sequestering CO2 by planting 50,000 trees by 2026.
- IV. Achieving a 20% reduction in Coal Consumption Intensity by 2028, using 2021 as the baseline year.
- V. Achieving a 30% reduction in Coal Consumption Intensity by 2032, using 2021 as the baseline year.

#### 4.3 Sustainable Sourcing:

- I. Source raw materials from suppliers committed to sustainable and ethical practices.
- II. Prioritize certified and renewable resources. Conduct supplier audits for ESG parameters and initiatives, ensuring all partners align with our sustainability and ethical standards.
- III. Continue to procure 100% wood pulp (raw material) from FSC-certified sources.

#### 4.4 Waste Reduction:

- I. Develop and implement strategies to minimize waste generation at the source.
- II. Promote recycling and reuse of materials. Encourage the use of recycled and sustainable materials.

#### 5.1 Eco-friendly Processes:

- I. Adopt production methods that minimize emissions, effluents, and waste. Integrate clean technologies and best practices to enhance sustainability.

### 6.1 Targets For Responsible Disposal:

- I. Recycle 50% of raw material packaging by 2030 (baseline year 2021).
- II. Reduce solid waste intensity (going to landfilling) by 20% by 2028 (baseline year 2021).
- III. Reduce solid waste intensity (going to landfilling) by 30% by 2032 (baseline year 2021).
